Who can apply

- Small, medium or large private sector enterprises in Bahrain
- Active enterprises established according to laws and regulations
- Those not already taken the Business Information Scheme (BIS)
- For non-Bahraini enterprises, a minimum of 25% Bahrainisation rate is required.
- Enterprises who have not been audited before
- Enterprises with proper book-keeping can only apply for auditing services.

What you need

- Copy of the Commercial Registration Certificate and/or licence
- Copy of owner ID
- Copy of guarantor letter (if any)
- For companies: memorandum/article of association and the signatory authorisation letter (if any)
- Latest fees invoices & receipt (suspended until further notice)
- 3 months bank statements
- Latest electricity bill
